# Mission & Impact

## Statements

### **Mission**

Through concerts and educational outreach, the Gateway Chamber Orchestra provides a fresh approach to masterworks of the past and present, thereby enriching the lives of audiences in Middle Tennessee.

### **Background**

The Gateway Chamber Orchestra (GCO) was formed as the Gateway Chamber Ensemble in the fall of 2008 around the performance faculty of Austin Peay State University (APSU), members of the Nashville Symphony and other top professional musicians from around the region. In the ensuing five years the ensemble grew to a classically modeled chamber orchestra of 33 musicians.

2010-11 marked the first subscription series and the adoption of a unique programming philosophy that pairs beloved masterworks with overlooked gems alongside works by contemporary American composers. Well-known masters such as Mozart, J.S. Bach, Beethoven and Brahms have appeared with composers such as C.P.E. Bach, Franz Schreker, Louis Spohr. Dedicated to presenting works by contemporary American composers, the GCO has performed works by William Bolcom, Ellen Taaffe Zwilich, and Steve Reich among many others.

Initially funded through APSU, the GCO moved out from under the auspices of the University in 2012 to develop its own identity with an independent volunteer board.

Committed to innovative educational outreach, the Gateway Concert Experience brings its ensemble members to public school instrumental classes in the weeks prior to concerts to present on the works from upcoming programs and to actively involve students in making music at a high level. Those students are then given the opportunity to attend the concert with their director and parental chaperones at no charge. Through this program, the GCO has reached over 3,000 students.

In 2012, a new Children's Concert provided 1,200 public school students the opportunity to see a multimedia performance that combined their own art with live music by the GCO. This annual event was expanded in 2013 to include a Family Concert that featured pre-concert opportunities for instrument exploration and craft projects for children.

In 2013, the four concert series, having previously been staged exclusively in Clarksville, was expanded for repeat performances in various Nashville locations including the Downtown Presbyterian Church and the Freemasons Auditorium at the Grand Lodge of Tennessee.

The GCO has released two CD recordings on the Summit label that have been lauded in Fanfare Magazine, American Record Guide and on various online sites. Producer Blanton Alspaugh won the 2013 GRAMMY for Classical Producer of the Year with the 'Chamber Symphonies' recording.

## **Impact**

In 2015-16 the Gateway Chamber Orchestra built upon the artistic activities of the previous seasons and developed significantly improved infrastructure for the future. Of particular note was the relocation of the previous downtown Nashville Monday evening Masterworks series to the Franklin Theatre in Franklin, Tenn.

Attendance for all series (Clarksville Masterworks, Franklin Masterworks and Family Series) exceeded the previous season. On the Masterworks series three premieres were presented including a consortium commission with the Detroit and North Carolina symphonies. The Family Series was partially supported by our first ever grant from the National Endowment for the Arts for audience engagement and featured visual artists Black & Jones, author Anna Celenza and pianist Jeffrey Biegel. New sponsors came on board and the organization was delighted to have the final Clarksville program named Gateway Chamber Orchestra day by both the city and county governments of Clarksville and Montgomery County.

2015-16 unfortunately saw the group operate with its first deficit, which has been met with significant effort to eradicate. As of this writing the organization has commitments to more than double corporate sponsorships from the previous season. The organization has also received its first civic support with the City of Clarksville recognizing the dramatic impact the organization has on the community. The incorporation of three new principal players will be our most significant artistic challenge. Growth in the Franklin market is the most pressing challenge for the business side of the organization. The continued need of an Executive Director remains the largest single hurdle to overcome.

## **Needs**

To ensure continued growth and success, the Gateway Chamber Orchestra needs:

- 1) Enhanced infrastructure in the form of part-time office staff and significantly greater expenditures on marketing in order to continue the growth trajectory of the GCO, particularly in Franklin.
- 2) Corporate sponsorship and individual donations to help sustain our concert series, family and children's concerts, and educational outreach programs.

The budget to facilitate the hiring of an Executive Director to run the business side of the organization (currently handled by a volunteer board of directors).

The Gateway Chamber Orchestra performs concerts in Clarksville and Franklin. Through educational outreach programs, the GCO brings its musicians to perform for and engage in hands-on activities with students at schools in Montgomery, Davidson and surrounding counties.

### **CEO Statement**

As Music Director of the Gateway Chamber Orchestra I have been amazed by the artistic trajectory of the ensemble. From the downbeat of our first rehearsal in 2008, in Schoenberg's daunting first Chamber Symphony no less, I think we all new we were experiencing something unique and special. This fascinating mix of kindred spirits has the opportunity to gather a handful of times per year in literature that is equal parts familiar and totally foreign to produce some of the most exhilarating moments of my professional life.

Reading Jerry Dubins review of our 'Wind Serenades' disc, we found the ensemble chosen "out of the pack" above leading ensembles from Vienna, London and New York - this for a start-up based firmly in Middle Tennessee. World-renowned flutist William Bennett was astonished at our eagerness to collaborate in a fashion the he felt rivaled the English Chamber Orchestra. Tackling works from the massive (Mahler's 'Song of the Earth') to the youthful (Britten's 'Simple Symphony') has been done with a healthy dose of classical tradition (LOTS of Haydn, Mozart and Schubert) and works that have stretched all of our boundaries (Henry Brant and the previously mentioned Schoenberg come to mind.)

But it is in the wide ranging educational efforts of rolling up our sleeves to head out into the country and visit students in rural Stewart and Houston counties as well as collaborating with visual artists Black & Jones to create an entirely new genre of family entertainment that we have come to realize the importance of developing a love for great art in students of all ages. Classical music is a wondrous form of art and I am constantly reminded of its power when students have an opportunity to interact with it in real life. Filling Mabry Hall in Clarksville for successive concerts twice in a row on a Monday morning is exhausting, but never in that moment. Seeing students react to the Tortoise movement from Saint-Saëns' Carnival of the Animals while watching their own drawing come to life on a 30-foot by 30-foot screen is truly priceless. I hope you will help us as we bring world-class art to the Middle Tennessee community.

## Programs

### Subscription Concert Series

**Description**

The GCO's performances employ a distinctive programming philosophy with three components – established masterworks, overlooked treasures, and contemporary American works. Each program is performed twice on Sunday afternoons in Mabry Concert Hall on the campus of Austin Peay State University in Clarksville and on Monday evening in various locations in Nashville. The GCO's performances have been praised in regional media such as the Leaf Chronicle and ArtsNash as "unfailingly sensitive," "achingly beautiful" and "polished perfection." Concerto soloists are drawn from the ensemble pool, as well as internationally acclaimed artists such as flutist William Bennett and clarinetist Charles Neidich. The 2015-16 season will be titled "My City" and include performances of works by three Middle Tennessee composers, as well as the world premiere of a work by Judd Greenstein based on poetry by Walt Whitman written for the GCO.

### Gateway Concert Experience Outreach Programs

**Description**

Committed to innovative educational outreach, the Gateway Concert Experience brings members of the GCO to public school instrumental rehearsal rooms in the weeks prior to concerts to present on the works from upcoming programs and to actively involve students in making music at a high level. Those students are then given the opportunity to attend the concert with their director and parental chaperones. The GCO has reached over 3,500 students in their classrooms since 2010 in various Middle Tennessee communities including Montgomery, Houston, Stewart, Davidson, Cheatham, Robertson and Rutherford counties.

## Family & Children's Concerts

<b>Description</b>	Beginning in 2012 a new Children's Concert provided 1,200 public school students the opportunity to see a performance in Mabry Hall at APSU in Clarksville at no charge to the school districts. The GCO collaborated with visual artists Black & Jones who collected art submitted by elementary students based on the program's works and brought them to life with animation. They then combined these animations with live video feed and various video loops to create an innovative multi-media presentation to display simultaneously with live music by the GCO. This annual event was expanded in 2013 to include a Family Concert that featured pre-concert opportunities for instrument exploration and craft projects for children. 2014 saw the first collaboration with an author when the GCO welcomed Anna Celenza to read from her children's book "The Farewell Symphony" as part of the performance. 2014-15 also include the addition of a second Family and Children's Concert featuring flutist Rhonda Larson as well as the first staging of a Nashville Children's concert. 2015-16 will see the continuation of a two concert Family and Children's series with the return of artists Black & Jones and author Anna Celenza for two unique programs.
