Mission

The Nashville City Cemetery Association, Inc. is a membership organization which works to protect, preserve, restore, and raise public awareness of and educate on the Nashville City Cemetery in collaboration with the Historical Commission of the Metropolitan Government of Nashville and Davidson County, Tennessee.

Background

Opened in 1822, the City Cemetery is the oldest continuously operated public cemetery in Nashville. A walk through the cemetery is truly a walk through Nashville's history. The gravestones tell the stories of individuals and families from the 1820s to the present day.

On March 9, 1820, the Mayor of Nashville and the Aldermen purchased from Richard Cross four acres of land located "on the plains, south of town, for its burying ground." The cemetery opened on January 1, 1822.

Fourteen years later the cemetery had outgrown its original site and more acres were acquired. By 1850 the cemetery was the final resting place for over 11,000 people of every race, religion and economic status. Since the opening, there have been 20,000 interments in the City Cemetery. Over the years, there have been removals -- 3,000 Federal soldiers from the Civil War were removed to the National Cemetery on Gallatin Pike, 480 Confederate soldiers were removed to Confederate Circle at Mt. Olivet Cemetery on Lebanon Pike, and families removed loved ones to new family lots in Mt. Olivet Cemetery after the Civil War. Four of Nashville's founders, James and Charlotte Robertson and John and Ann Robertson Cockrill; four Confederate generals: Felix Zollicoffer, Bushrod Johnson, Richard Ewell, and Samuel Read Anderson; the man who named the American flag "Old Glory", Captain William Driver; Union Navy Commodore Paul Shirley; a Tennessee Governor, William Carroll; 15 mayors of Nashville, and two of the original Fisk Jubilee Singers, Mabel Lewis Imes and Ella Sheppard Moore, are among the interesting people buried in the small and peaceful cemetery.

The City Cemetery was listed in the National Register of Historic Places in 1972 because of its historical and architectural significance. Come visit the Cemetery. Walk down the lanes and you will begin to feel that you have stepped back in time. Its quiet beauty can provide an escape from the busy world outside its walls.

The Nashville City Cemetery is located at 1001 Fourth Avenue South, at the corner of Fourth Avenue South and Oak Street. The Nashville City Cemetery is open from 8:00 a.m. until 5:00 p.m. seven days a week, all year. There are signs within the Cemetery and an informational board in the breezeway of the Keeble Building to assist visitors with self-guided tours.

Impact

The Nashville City Cemetery Association has assumed a greater role in the day-to-day repair and restoration of the Nashville City Cemetery in conjunction with the Metropolitan Historical Commission and Metro Parks. In the last year, the Association has paid to restore vandalized tombstones, to plant trees, recreate cedar grave markers, and to provide upkeep and maintenance in addition to that provided by Metro Parks. (In 2010 the \$3.5 appropriation made by the Metropolitan Council to repair and restore the City Cemetery was exhausted, and the Cemetery is now restored as best could be done to its nineteenth century appearance.)

The Association's educational programs have been extremely successful:

- In June 2013 the Nashville Tree Foundation designated the Nashville City Cemetery as an arboretum at a ceremony held onsite. We also created an educational brochure which allows individuals to tour the arboretum employing the map and index within.
 - In May, 2017 the Nashville City Cemetery Association and the Nashville Striders co-sponsored the 20th annual Memorial Day Dash 5K run/walk. All proceeds of this most successful event benefit the continuing restoration and preservation of the City Cemetery.
 - Throughout the year, the Association organized specialized tours of the Cemetery. In May, the Davidson County Master Gardeners (who have made the Cemetery their project) led a tour that focused on the cemetery gardens.
- In October, the popular and successful annual Living History tour was held. Local actors in period costumes portrayed some of the city's most interesting early citizens now buried on the site in Nashville.
 - We sell copies of a revised history book written in 2010, Nashville City Cemetery.
 - The Association publishes a semi-annual newsletter which includes articles on the Cemetery's history and describes past and upcoming events.

We will continue these activities in the year to come.

- In conjunction with the Tennessee Historical Commission and the Tennessee Department of Transportation we hope to place the Cemetery on Tennessee Civil War Trails.
- In conjunction with the Metro Parks we hope to have the Cemetery designated as a greenway. We developed a mobile app that will allow visitors on and off site to tour the cemetery and learn about its residents.
- Volunteers are working monthly to maintain the Cemetery, removing trash, brush, dead limbs, etc. This is in addition to the regular mowing and trimming done by Metro Parks.
- We will continue to spend money for repair and upkeep of the Cemetery.

Needs

Our most pressing need is to raise funds for continuing restoration efforts. Our annual fund raisers, the Living History Tour, the Memorial Day Dash, and the Membership Drive all contribute to our on going efforts on behalf of Nashville City Cemetery preservation. Membership support is critical in making this happen. Another area of need is volunteer support. Volunteers are needed for the Living History Tour, the Memorial Day Dash, Clean Up Days, and Special Events.

Other ways to donate, support, or volunteer

Board Chair Statement

When a group of very determined people founded Nashville City Cemetery Association in the early 1990's when the Cemetery was an overgrown and neglected relic of the Nashville's past. Due to bizarre views on how contagion was spread, it had effectively ceased to be a working cemetery in the 1880's. Tombstones had been damaged or destroyed due to vandalism, overgrowth, and air pollution. Homeless people camped out between the graves, and drug users used it as their playground.

Today the Cemetery is one of the gems of Nashville's park system. Association members, through aggressive grass roots action, prompted government officials to mow the Cemetery and clear out brush. The Association lobbied for and obtained a \$3.5 million appropriation for City Cemetery from the Metro Council in 2006 to restore and upgrade the Cemetery. Tombstones and mausoleums were repaired. Roadways were paved. Security lighting was installed.

Members of the Association conduct many activities to educate the public about City Cemetery and its history. These efforts include the annual Living History tour, specialized tours, a book, and a newsletter.

This mission continues even though the appropriation has been exhausted. The Association has undertaken to pick up where government left off, and to do this it needs money. While the Association conducts fund raisers that bring in almost \$10,000 per year, it needs donations to help in this mission.
