THROUGH A PROGRAM CALLED THE GATEWAY CONCERT EXPERIENCE, PERFORMERS IN THE ENSEMBLE VISIT STUDENTS IN THEIR PUBLIC SCHOOL MUSIC CLASSROOMS (GENERALLY MIDDLE TENNESSEE AND WESTERN KENTUCKY SCHOOLS) TO FACILITATE HANDS-ON OUTREACH PROGRAMS, REACHING OVER 1,500 STUDENTS.
