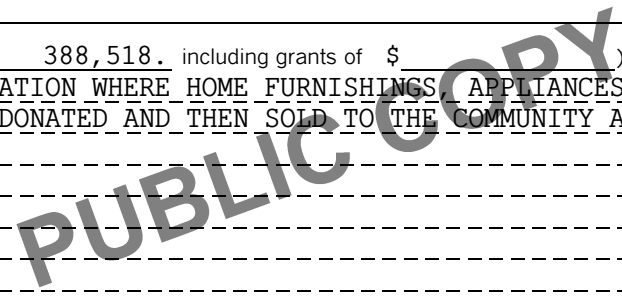

THE HOMES ARE BUILT BY VOLUNTEERS WITH QUALIFYING FAMILIES PROVIDING 500 HOURS OF LABOR ON EITHER THEIR HOMES OR OTHER HABITAT HOMES. LABOR, LAND AND BUILDING MATERIALS ARE PROVIDED BY SUPPORTERS.

ORGANIZATION MISSION PROGRAMS CONSTRUCTED 12 HOMES AND SERVED 31 FAMILY MEMBERS PROVIDING AFFORDABLE HOMES FOR THEM. OVER 1,500 VOLUNTEERS FROM CHURCHES AND BUSINESSES DONATED THEIR TIME ON OVER 5,000 DAYS IN BUILDING THESE HOMES AND SUPPORTING OUR MISSION. ONE COMPLETE HOME WAS BUILT AND PAID FOR BY A COLLABORATION OF A HOME BUILDER AND A REAL ESTATE COMPANY.

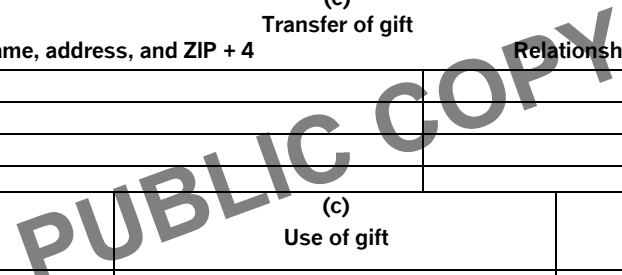

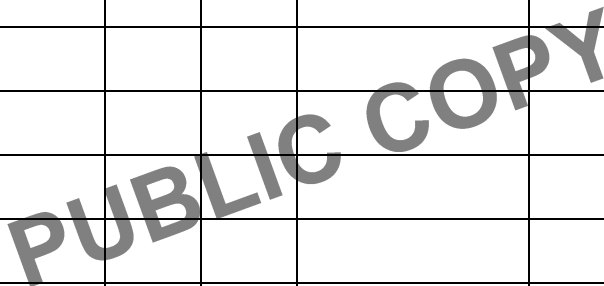

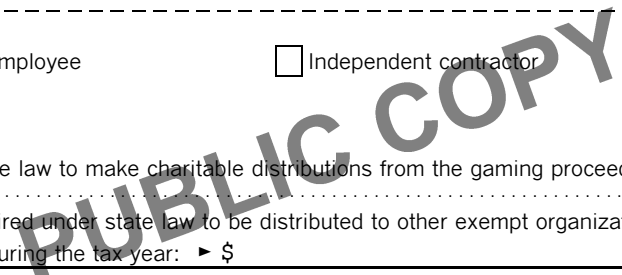
