THE HOMES ARE BUILT BY VOLUNTEERS WITH QUALIFYING FAMILIES PROVIDING 500 HOURS OF LABOR ON EITHER THEIR HOMES OR OTHER HABITAT HOMES. LABOR, LAND AND BUILDING MATERIALS ARE PROVIDED BY SUPPORTERS.

ORGANIZATION MISSION PROGRAMS CONSTRUCTED 13 HOMES AND SERVED 38 FAMILY MEMBERS PROVIDING AFFORDABLE HOMES FOR THEM. OVER 1,500 VOLUNTEERS FROM CHURCHES AND BUSINESSES DONATED THEIR TIME ON OVER 5,000 DAYS IN BUILDING THESE HOMES AND SUPPORTING OUR MISSION. 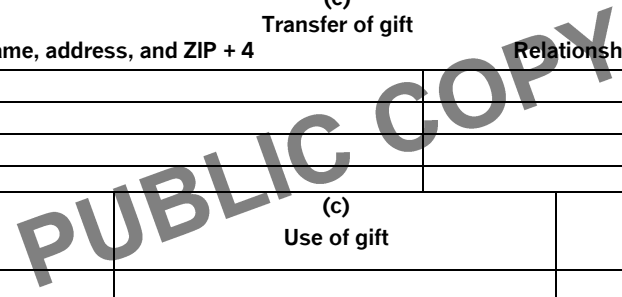
