THE HOMES ARE BUILT BY VOLUNTEERS WITH QUALIFYING FAMILIES PROVIDING 500 HOURS OF LABOR ON EITHER THEIR HOMES OR OTHER HABITAT HOMES. LABOR, LAND AND BUILDING MATERIALS ARE PROVIDED BY SUPPORTERS.

ORGANIZATION MISSION PROGRAMS CONSTRUCTED 8 HOMES AND SERVED 36 FAMILY MEMBERS PROVIDING AFFORDABLE AND SAFE HOMES FOR THEM. OVER 2,000 VOLUNTEERS FROM CHURCHES AND BUSINESSES DONATED THEIR TIME ON OVER 150 DAYS IN BUILDING THESE HOMES AND SUPPORTING OUR MISSION.
