THE HOMES ARE BUILT BY VOLUNTEERS WITH QUALIFYING FAMILIES PROVIDING 500 HOURS OF LABOR ON EITHER THEIR HOMES OR OTHER HABITAT HOMES. LABOR, LAND AND BUILDING MATERIALS ARE PROVIDED BY SUPPORTERS.

THE ORGANIZATION'S MISSION DRIVEN PROGRAMS CONSTRUCTED 10 NEW HOMES AND REHABILITAED ONE HOME TO SERVE 37 FAMILY MEMBERS BY PROVIDING AFFORDABLE AND SAFE HOUSING. OVER 2,000 VOLUNTEERS FROM CHURCHES AND BUSINESSES DONATED THEIR TIME ON OVER 150 DAYS TO CONSTRUCT THESE HOMES AND SUPPORTING OUR MISSION.
